As lawful consideration for being permitted by Camp La VidaSM and Woman's Missionary Union, Auxiliary to South Carolina Baptist ConventionSM, (hereinafter "Released Parties"), to participate in camping and related activities and use their facilities, I hereby agree that I, my heirs, distributes, guardians, legal representatives, and assigns will not make a claim against, sue, attach the property of, or prosecute the Released Parties and/or any of their shareholders, officers, directors, agents, employees or others for injury or damage (including, but not limited to illness, personal injury, disability, or death) resulting from the negligence or other acts, howsoever caused, by any employee, agent, officer, director, shareholder, or other, as a result of my participation in camping and related activities. In addition, I hereby release and discharge the Released Parties, their officers, shareholders, directors, employees, agents, and others from all actions, claims, or demands I, my heirs, distributes, guardians, legal representatives, or assigns now have or may hereafter have for injury or damage resulting from my participation in camping and related activities. Furthermore, I agree to indemnify and hold the Released Parties harmless as to any claims, losses, settlements, judgments, costs, and expenses (including attorney's fees) arising in any way from my participation in the activities described above.

SAFETY PROCEDURES - Canoeing

All participants in canoeing activities must pass the swim test at the pool in addition to the canoe test. The canoe test requires that the camper tread water for three minutes. Before the activity begins, rules for canoeing are reviewed. The posted rules include:

1. Obey lifeguard

3. Always wear lifejacket (PDF)

2. No standing in canoe

4. No horseplay

Instructions are given before canoeing begins. Lifeguards give instructions on getting into the canoes, using the throw rope, moving positions, etc.

Wheelchairs are not allowed on the dock or within 8 feet of the water's edge.

EMERGENCY PROCEDURES - Canoeing

- A. Steps to follow if someone falls into the lake:
 - 1. Reach the paddle to them
 - 2. Use the throw rope
 - 3. The lifeguard goes into the water to rescue the person
- B. If a person is suspected missing:
 - 1. Alert staff in the immediate area to assist in the search
 - 2. Calmly get all swimmers and boats out of the water
 - 3. Ask campers and other staff about the last area the camper was seen
 - 4. Enlist as many staff as possible in the search
 - 5. Notify camp personnel about the situation
 - 6. Enlist staff and campers to search ground areas
 - 7. Alert the local rescue squad
